Rev Dr Praveen Martis SJ is the new Principal of St Aloysius College

Rev Dr Praveen Martis S J is appointed as the Principal of St Aloysius College (Autonomous), Mangaluru and he assumed the office of the Principal on April 17, 2017. The incumbent Principal Rev Fr Swebert D'Silva SJ who has attained superannuation, handed over the office to the new Principal in a Pro-



gramme arranged in the college in the presence of Rev Fr. Dionysius Vas SJ, the Rector of St Aloysius Institutions.

Rev Dr Praveen Martis hails from Shankerpura, Udupi District. After finishing his early education from St. John's Educational Institutions, Shankerpura and Pre-University from St. Mary's College, Shirva, he was graduated from St Aloysius College, Mangaluru and completed post-graduate degree in Chemistry from St Joseph's College, Bengaluru. He did his doctoral studies in the Department of Chemistry and Electrochemistry of Sur-



faces, University of Namur, Belgium and obtained his Ph D degree for his thesis on "Multiwalled Carbon Nanotubes: Decorated with metal nanocrystals and incorporated into metal matrices." in 2011. A well-known research scholar in Chemistry he has several research paper presentations and publications. To his credit he has more than 15 international publications in

peer reviewed reputed journals.

Rev Dr Praveen has rich experience in teaching and administration. During his religious studies he was entrusted with the responsibility of Assistant Director of Loyola Pre-novitiate, Mangalore. After his ordination in 2005, He was appointed as the Correspondent and Student counsellor at St. Joseph's Evening College, Bangalore. He began teaching career in the year 2007 at St. Joseph's Institutions, Bangalore as lecturer in chemistry. During the same period he also held the offices of Assistant Director of Ashirvad, Bangalore. Known for his leadership qualities and intellectual expertise he has been shouldering various administrative posts in the Karnataka Jesuit province. To name a few in 2011, he



was promoted to the post of Director of Post Graduate and Research Centre in St Joseph's College, Bengaluru. He also served as the Rector of St Joseph's College, Bengaluru from 2012 – 2014. In 2013 in addition to this responsibility he was appointed as the Principal of St Joseph's College (Autonomous), Bengaluru. In 2015 he was transferred to St Aloysius College (Autonomous) Mangaluru as Vice Principal, Campus Minister and the Director of DDU Kaushal Kendra. He is instrumental in initiating the skill based B Voc degree programmes. He also serves as the consultant to the Provincial of Karnataka Province and Secretary of Mangalore Jesuit Educational Society.

INDUSTRIAL VISIT BY M.Sc (SOFTWARE TECHNOLOGY) STUDENTS

The M.Sc (Software Technology) department of St. Aloysius Institute of Management and Information Technology had Organised an Industry tour of 4 days for thirty students of second semester of MSc-Software Technology, who were accompanied by three faculty members Mr Ruban, Ms Suchetha Vijaykumar and Mr Shrinivas. This tour consisted of visiting IT companies like IBM, JDA and CDAC in Bengaluru and food processing units like CFTRI and CSRTI in Mysore.

Objective of the Industry Visit:

Industrial visit has its own importance in a career of a student who is pursuing a professional degree. Objective of this industrial visit was to provide a platform for the students to gain a first-hand information and a better insight regarding internal working of companies and also to open up the students with opportunities to plan, organize and engage in active learning experiences and team building.



The Industry Visit journey:

On the pleasant evening of 4th April 2017 at 8:40pm the group boarded the train departing to Bengaluru and reached their destination at 5th April 2017, 8:00am.

The visit started in the early hours of a working day of 5th April itself where the students first had an active interaction in St. Joseph College of Business Administration with Fr Manoj D'Souza SJ about the Jesuit ways of learning and also the history of the Institution. Father also shared his own experience of teaching in AIMIT and wished the whole group the very best for their rest of the expedition.

The team then proceeded towards IBM, Embassy Golf Links Business Park. After a thorough security check students were taken towards the training lab next to the Power8 Servers where they were acquainted with how they could utilize and integrate high-performance cloud infrastructure and cutting-edge services into an IT environment with the IBM Bluemix cloud platform and also about different types of APIs they could make use of to improve their projects. This session was not only good at informative level but also gave the students a better visualization on how they can implement and incorporate cognitive services to drive business value quickly and inexpensively.

On the second day of the visit they were taken to Centre for Development of Advanced Computing (C-DAC) where the group was briefed upon the various courses the students can undertake in C-DAC as an add on to their

profile and to boost up their IT knowledge practically.

They were taken to see the Param-Padma Supercomputer incubators and briefed upon their working. Students also interacted actively to know more about supercomputing work held in India and worldwide.

The same afternoon students visited JDA where they met and interacted with few JDA officials as well as few AIM-IT alumn is currently working in JDA and also those who are pursuing their internship in JDA. Students were notified on the current working and status of their way of business and also were informed about the general way interviews in JDA for hiring. Students were impressed and motivated not only by the session but the overall vibe they got from their seniors and hence are looking forward to work more hard to achieve their goals better.

The next early morning students left to Mysore were they visited Central Food Technological Research Institute (CFTRI) on the first day to know how even things like Spirulina (found in almost all our backyards during rainy season) which is natural "algae" (cyanbacteria) powder that is incredibly high in protein and a good source of antioxidants is processed and also how the group as IT students can help in R & D towards these areas.

On 8th April the group visited Central Sericultural Research & Training Institute (CSRTI) and learnt about different ways silk is cultivated using Sericulture and widening their horizons outside IT so that it could help them to think out of the box to merge IT with Sericulture. The journey was filled with enthusiasm and urge to learn more.

The college had arranged facilities of local traveling with college bus from St Josephs College to assist the group in their tour in Bengaluru. The students stayed at Ashirvad Jesuit House in Bengaluru for two days and then moved on to Mysore where they were assisted by college bus from St Philomena PU College and stayed in Organization for the Development of People (ODP) for the next two days.

Students were thankful to their faculties for organizing such an informative event and guiding them throughout



their journey. This journey will play a crucial role in developing their practical skills and widening their thought spectrum in the field of IT. This opportunity helped them to learn practically through interaction, working methods and employment practices. It gave them the exposure to current work practices as opposed to possibly theoretical knowledge being taught at college.

Session on Digital Transformation

Ms Anita Punja conducted sessions as part of a certificate course on Digital Transformation as it is currently impacting business, education and common people across the globe. She has worked for Leading Technology, Media & Consulting organizations such as IBM, STAR TV, Viacom, Times of India in the past and also served some of these companies overseas. Her last assignment was in USA for several years. Her specialization is in Digital Transformation at enterprise and functional level by using Emerging Technologies

As part of her lecture series she focused on retailers and manufactures who can sell their products more easily through web portals as it saves money on inventory and middle men. "There are companies that have gone from



brick and mortar to e-marketing (lifestyle) and there are companies that have gone from e-marketing to brick and mortar (lenskart)", she added. Students found the course to be interesting, entertaining and industry oriented.



Radio with a difference

Community radio Sarang is riding air waves eight years since its launch, thanks to its connect with the man on the street

Radio Sarang is on air for 16 hours daily, it also went live for 24 hours making it the only community radio to do so. It has ad-free programmes in 5 languages including Kannada, Konkani, Tulu, Beary and occasionally in English

The radio covers a range

65km, going as far as Kasargo and Puttur

In 2012, it won a national award from among 130 community radio stations for the best programme in promoting local culture for its programme in Beary language LIKHITH SHENOY@Mangaluru

EIGHT years ago, it was launched as a community radio by Mangaluru's St Aloysius College. Today Radio Sarang is growing strong and, as its tagline says, "celebrating the colours of life" on 107.8 FM. Founded by Fr Rich



ard Rego, the community radio has seen several changes in its programming format, but its underlying theme has been to give a voice to local people, communities, cultures and issues. It has also been a launchpad for many radio jockeys (RJ), and a guiding and entertaining force to its listeners who belong to different strata of society.

What sets the radio apart is the voice that it gives to the unheard and unsung. Sudhama, a goldsmith on Car Street, is an avid Radio Sarang listener. "When I first tuned in to Sarang it impressed me. I never knew there was a radio that can become the voice of people like us. Its programmes are closer to society and real. The pains and emotions of the common man are brought

Santrapti focus on us and make t an attempt to make others know more about the nature of our jobs, lives and problems," he said.

Programmes like Beedida Baduku, focusing on the lives of beedi workers, Namma Sarang Nimmedege, where radio jockeys reach out to people from all walks of life in and around Dakshina Kannada, or the newer Vratti Santrapti, which features all kinds of professionals like sho or watch repairers, potters, tailors, goldsmiths and so on, have touched a chord with listeners. By featuring such unsung people who touch our lives every day, the radio acts a bridge too.

Abhishek Shetty Padil, programme producer at Radio Sarang, says, "The people we meet during the recording are so humble and grounded that we feel an instant connect. They are the ones who speak from their hearts and are open-minded."

It also addresses a wide range of civic issues and offers corporators and complainants a common platform. Many visually challenged listeners form a chunk of the radio's fan brigade.

The marginalised sections like transgender too will be highlighted in a new programme planned by the radio. Thimmappa Kadaba, a programme producer, said, "We are encouraged by the response to our programmes. We'll be trying to highlight as many people as we can across various spectra."

It has also gathered a lot of attention from the public Also, frequent listeners call in and participate in the live shows. Jayaprakash Yekkur, who works in a laundry shop, said, "Sarang reaches out to that section of society unknown to the larger spectrum of people. It's ad free. It promotes Yakshagana and plays old songs on request. Being a listener for the past five years, I expect it to bring the politicians and the public more closer through its programmes."

Radio Sarang has also been a breeding ground for many RJs. RJ Rashmi, who now works for a commercial radio station, says, "Sarang introduced a whole new world to me. Five years later, people still call in and recognise me as the RJ at Sarang, I anchored the song based Volavina Haadu programme."
